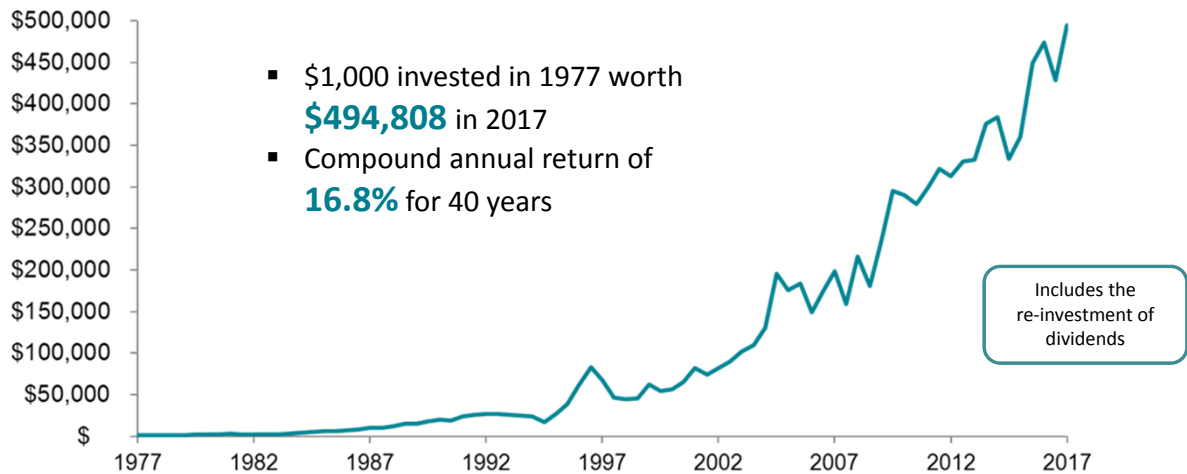

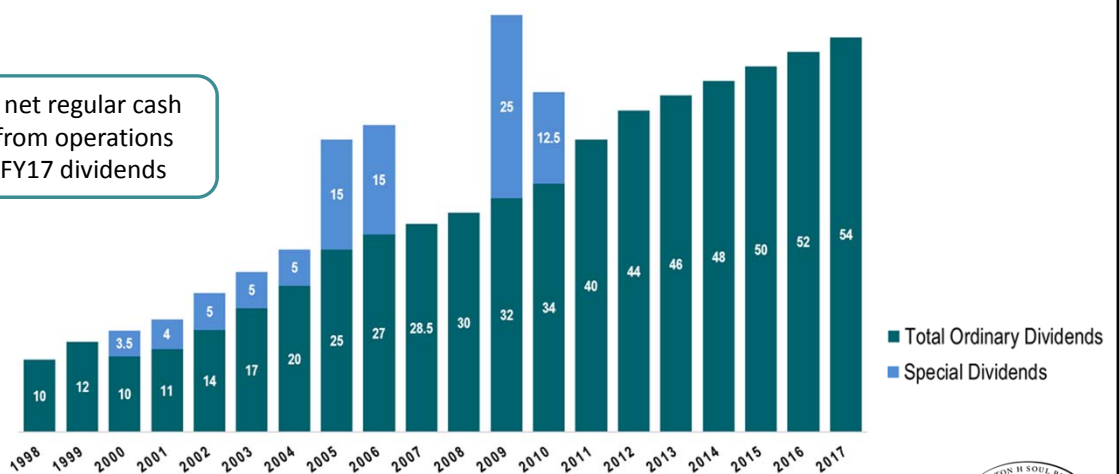


20 Year Dividend History
